Exhibitor shall hold the Lancaster County Convention Center and EQXPO, LLC harmless and shall indemnify the Lancaster County Convention Center and EQXPO, LLC against all liability or expenses arising out of any claim of injury or damage to any person or property, together with all costs in connection with the defense thereto, including attorney's fees.
2. SET-UP: Set-up of booths must be complete at show opening and must remain set up and open for business until show closing. Booths and aisles must be kept clear for safe access throughout show hours.
3. The Lancaster County Convention Center, EQXPO, LLC reserves the right to demand removal by an Exhibitor of any items which may not be in keeping with the show's image. Exhibitors must provide consumers with receipts that include Exhibitor's name and phone number. All items for sale must have legible price tags.
4. The Lancaster County Convention Center, EQXPO, LLC reserves the right to make rules and regulations it deems proper and necessary and exhibitor agrees to accept such rules and regulations and any interpretation as is set forth by the Lancaster County Convention Center and EQXPO, LLC.
5. All municipal, state, and federal requirements in connection with sales must be fulfilled.

7. The use of porters, if available, to assist unloading and loading is at exhibitor's own risk, and The Lancaster County Convention Center and EQXPO, LLC shall not be liable for any resulting damage or claim.
8. Exhibitor warrants that exhibitor carries vehicle liability insurance for any vehicle that is brought onto the facility premises.
