I understand that I have contracted for exhibit space by signing this contract and I am liable for the full cost of the booth space. I also understand that the final location of space will be determined by show management upon receipt of a 50% deposit or payment in full. The undersigned represents that he / she is fully authorized to execute and complete this contract.

The Exhibitor understands and agrees as follows:

1. Deposit of 50% is required with application.
2. CANCELLATIONS: If cancellation occurs prior to 90 days of a signed contract there will be a charge of \$200.00 per booth space. CANCELLATION MUST BE MADE BY CERTIFIED MAIL ONLY.
3. The Exhibitor will be liable for the entire contract price for any contract cancelled after 90 days of a signed contract.
4. No Cancellation refund after 90 days of a signed contract.
5. In the event of default by exhibitor, exhibitor agrees to pay collection costs including reasonable attorney's fees.
6. The Greater Philadelphia PET EXPO (GPPE), Long Island Pet Expo (LIPE), Meadowlands Pet Expo (MPE), Reading Pet Expo (RPE), Family Pet Expo (FPE) and GARRI PROMOTIONS , its agents, officers or employees, shall not be liable for property damage or personal injury to Exhibitor, its agents, employees, helpers &/or guests, which may occur on or about any part of the subject premises including your booth space, regardless of how such an injury or damage may have occurred. Exhibitor waives any claim against the GPPE, LIPE, MPE, RPE, FPE, and GARRI PROMOTIONS , and assumes all liability for loss or damage to exhibitor's property entrusted to the premises. Exhibitor shall hold the GPPE, LIPE, MPE, RPE, FPE and GARRI PROMOTIONS harmless and shall indemnify the GPPE, LIPE, MPE, RPE, FPE and GARRI PROMOTIONS against all liability or expenses arising out of any claim of injury or damage to any person or property, together with all costs in connection with the defense thereto, including attorney's fees.
7. Every exhibitor is required to carry "All Risk" insurance on liability, products and equipment while in transit to and from, and while in the exhibit area. This will protect you and your exhibit. GARRI PROMOTIONS, its officers and employees are to be named as additional insured. You must contact your insurance agent for this coverage for the period of the GARRI PROMOTIONS . Since no inventory can be confirmed, your merchandise is your responsibility, protect it accordingly. Proof of Insurance must be supplied to GARRI PROMOTIONS prior to the show.
8. SET-UP: Set-up of booths must be complete at show opening and must remain set up and open for business until show closing. Booths and aisles must be kept clear for safe access throughout the regular show hours.
9. The GPPE, LIPE, MPE, RPE, FPE. and GARRI PROMOTIONS reserves the right to demand removal by an Exhibitor of any items which may not be in keeping with the show's image. Exhibitors must provide consumers with receipts that include Exhibitor's name and phone number. All items for sale must have legible price tags.
10. The GPPE, LIPE, MPE, RPE, FPE and GARRI PROMOTIONS reserves the right to make rules and regulations it deems proper and necessary and exhibitor agrees to accept such rules and regulations and any interpretation as is set forth by the GPPE, LIPE, MPE, RPE, FPE and GARRI PROMOTIONS .
11. All municipal, state, and federal requirements in connection with sales must be fulfilled.
12. This contract cannot be assigned without prior written consent of the GPPE, LIPE, MPE, RPE, FPE or GARRI PROMOTIONS .
13. The use of porters, if available, to assist unloading and loading is at exhibitor's own risk, and The GPPE, LIPE, MPE, RPE, FPE and GARRI PROMOTIONS shall not be liable for any resulting damage or claim.
14. Exhibitor warrants that exhibitor carries vehicle liability insurance for any vehicle that is brought onto the facility premises.
15. This agreement and performances here under, and all suits and proceedings here under shall be interpreted and construed pursuant to the laws of Pennsylvania, New Jersey and New York.
16. By signing the front of this Exhibitor agreement the Exhibitor agrees that they have read and understand all of the above rules and regulations and those that appear in the Exhibitor Manual for the Greater Philadelphia Pet Expo, Long Island Pet Expo, Meadowlands Pet Expo or Reading Pet Expo.
